The Connection Between Asbestos and Mesothelioma

Researchers have proven that there is a strong link between asbestos and mesothelioma. Long-term asbestos exposure is believed to be the primary risk factor for mesothelioma. It is believed that inhalation of asbestos dust causes irritation in the lungs. This irritation prompts the lungs to begin forming abnormal cells that accumulate and eventually form a tumor.

Isolated exposures to asbestos are not likely to lead to mesothelioma. Instead, researchers believe that long-term exposure allows the asbestos fiber to build up in the lungs over time, leading to the development of cancer. Some believe that a singular exposure of a certain magnitude could be sufficient to cause the formation of a tumor.

Who is at Risk?

Asbestos was previously used in a wide variety of applications, primarily because of its resistance to heat. It was used widely in many different industries and different products. Its use is far more limited today, and when it is used, it is handled with far greater care. However, people who have worked in the following industries may be at risk for developing mesothelioma:

Family members or anyone who lives with people who work with asbestos are also at risk of developing mesothelioma. The people who work with mesothelioma can carry home stray fibers and dust on their skin and clothing, exposing the people they live with. This exposure can build up over the years and eventually result in the development of mesothelioma.

- **Power plant workers:** Before the dangers became well-known, many workers were subject to [exposure in power plants](#) while working with products containing asbestos.
- **Shipyard employees:** Until the 1980s, asbestos was used extensively on products used to build ships. The combination of exposure and poor ventilation created a high risk of developing [asbestos-related diseases among shipyard](#) workers.

What Is Mesothelioma?

Mesothelioma is an aggressive form of cancer that affects the mesothelium, a membrane that lines several cavities within the body, including the lungs. In nearly all cases, it is caused by inhaled asbestos fibers getting lodged in these membranes.

Although asbestos is seldom used in materials anymore, thousands are still diagnosed with mesothelioma every year and millions more are at risk for developing the disease. This is because mesothelioma typically does not develop for 20 to 50 years after exposure to asbestos.

For individuals diagnosed with mesothelioma, it is important to obtain skilled legal advice as soon as possible. The First Step in Your Mesothelioma Lawsuit

Filing a mesothelioma claim is the first step in the legal process of seeking compensation for your injury. In the claim, the victim (claimant) names the company or business (defendant) at fault for causing their injury and requests compensation. The defendant must respond to the claim within a certain amount of time set by each individual state.

What Types of Claims Will a North Carolina Mesothelioma Law Firm Manage?

There are different types of claims that may be available for mesothelioma patients and/or their family members. You may be eligible for more than one type of claim depending on the circumstances of your particular case. An experienced North Carolina law firm professional is in the best position to advise you on what type of claim is best for your case, but the following is an overview of each type.

Personal Injury Claim for Asbestos Exposure

A personal injury claim is filed by the patient diagnosed with mesothelioma, or a lawyer on their behalf, in state or federal civil court. Because each state's civil code is different, it is important that your attorneys—like those at the Martin & Jones North Carolina mesothelioma law firm—regularly work with clients all across the country and

understand these variances. States have different time limits on when a case can be filed and vary in how they apply laws regarding negligence. Some states have limitations (caps) on settlement amounts.

Wrongful Death Claims May Also Be Pursued By Our North Carolina Mesothelioma Lawyers

A [wrongful death claim](#) is usually filed by the loved ones of a victim who passed away from mesothelioma. Family members who typically file a mesothelioma wrongful death claim include the decedent's spouse and children. Partners, legal heirs, executors specified in a will, adopted children and other dependents might also be able to file a wrongful death lawsuit. These survivors seek damages to compensate them for loss of companionship, loss of financial support, mental anguish and loss of consortium.

What Other Types of Claims Can a Mesothelioma Patient or Family Members File?

Other than personal injury claims, mesothelioma patients, in certain circumstances, can pursue trust fund claims or workers' compensation claims.

Mesothelioma Trust Fund Claims

Many of the companies that exposed workers to asbestos – manufacturers of asbestos products and builders that used asbestos products, for example – filed for bankruptcy to avoid paying claims to workers they harmed. The Chapter 11 bankruptcy process often requires these companies to create a trust fund to compensate their victims. There are many of these mesothelioma trust funds across the country. It is up to the claimant to identify the proper trust fund to file their claim against, and the lawyers at Martin & Jones can help with that process with their extensive knowledge of the different trust funds available.

Workers' Compensation Claims

For people exposed to asbestos while working and who later develop mesothelioma or other asbestos-related diseases, some states have workers' compensation systems that may provide compensation to them or their family members. Types of Mesothelioma and Symptoms

The most common locations of mesothelioma in the body are pleural and peritoneal.

Pleural mesothelioma is a cancer of the pleura, a membrane that lines the lung and the chest wall outside the lung. Most mesotheliomas are pleural mesothelioma. The next most common type is peritoneal mesothelioma which affects the mesothelium lining the abdomen. Pericardial mesothelioma affects the lining around the heart and is an extremely rare form of cancer.

Individuals with pleural mesothelioma may first notice shortness of breath and some chest pain, although in the early stages there may be no symptoms at all. Symptoms typically get progressively worse, including coughing, fever, fatigue, weight loss and pleural effusions (fluid buildup around the lung).

Individuals with peritoneal mesothelioma may first notice abdominal pain, bloating and swelling accompanied by diarrhea and/or constipation. Symptoms can progress to include fatigue, weight loss, nausea, night sweats and anemia.

Mesothelioma Diagnosis

Individuals who believe they have been exposed to asbestos should advise their doctors when discussing their symptoms. Typically doctors will initially diagnose mesothelioma using imaging equipment. An x-ray is the first type of imaging that may be used. X-rays are not as detailed as CT scans or MRIs, so they may miss mesotheliomas at their beginning stages. They are most likely to detect buildup of fluid in the pleural cavity surrounding the lungs, known as a pleural effusion.

Doctors may order a subsequent CT scan, which can look at layers of tissue. Biopsies of tissue are often required to confirm a diagnosis of mesothelioma.

Once mesothelioma has been diagnosed, doctors may use MRIs or PET-CT scans to detect the progression of the disease and response to chemotherapy.
