They are available to workers who are injured at work and while in the course of their work duties.

Perhaps most importantly, these benefits are available to injured workers regardless of fault. In other words, you do not need to prove that your employer or anyone else was at fault in causing the accident. You can receive workers' compensation benefits even if the accident was caused by your own negligence.

Workers' compensation benefits are available almost immediately. This means that you can get the compensation you need to pay your medical bills and replace your lost income without having to wait for weeks or months. This allows you to focus on getting the medical treatment you need without having to worry about paying your bills.

You do not need to hire an attorney to file a workers' comp claim. Many claims are denied, often because the worker did not submit the correct documentation or made some other mistake.
