

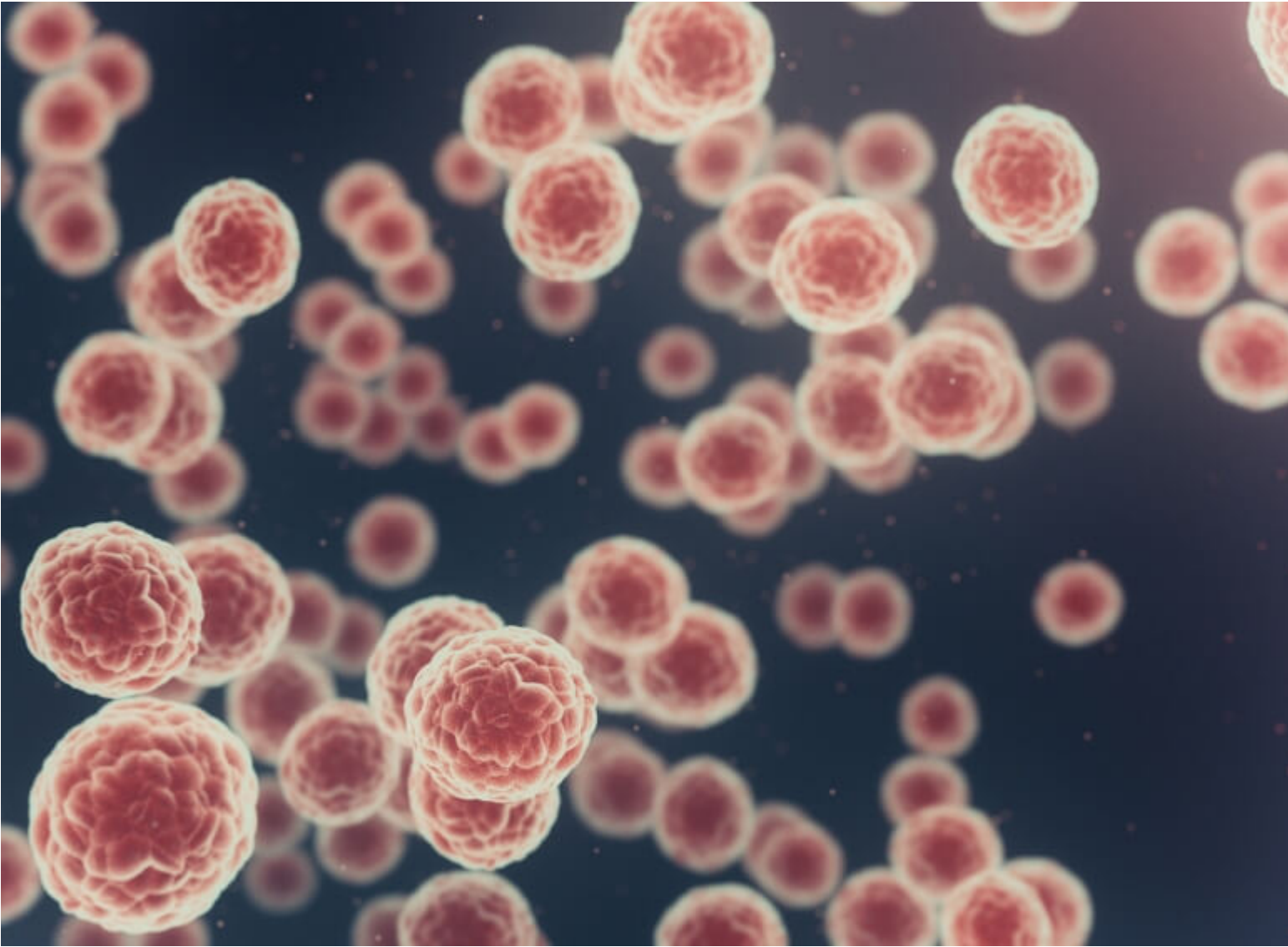
# Veterans and Family Members Need an Experienced Camp Lejeune Water Contamination Attorney

From 1953 to 1987, the water at Camp Lejeune in North Carolina was contaminated with multiple volatile organic compounds (VOCs). These VOCs left hundreds of thousands – and potentially more than a million – individuals suffering from a variety of serious illnesses. While limited benefits have been available to affected veterans and their families through the U.S. Department of Veterans Affairs (VA), eligible claimants can now recover additional compensation with the help of a Camp Lejeune water contamination attorney.

## Why Hire an Attorney to File Your Claim Under the Camp Lejeune Justice Act of 2022?

Enacted in August 2022, the [Camp Lejeune Justice Act](#) established a new source of financial recovery for veterans, contractors, family members, and other individuals affected by the contaminated water at Camp Lejeune.



### **What Caused the Water Contamination at Camp Lejeune?**

The water at Camp Lejeune was contaminated for an *extremely* long time—for more than 34 years from August 1, 1953 to December 31, 1987. One of the primary issues leading to the contamination at Camp Lejeune was that oil and industrial waste entered the groundwater. Government investigators also concluded that a dry cleaning business was dumping chemicals on the ground and that these chemicals were able to enter the water supply as well.

### **Chemical Waste in Camp Lejeune’s Water**

The water contamination at Camp Lejeune was the result of chemical waste. Specifically, federal investigators identified four VOCs in Camp Lejeune’s water linked to hazardous chemicals and the degradation of military, commercial, and consumer products:

- Benzene
- Tetrachloroethylene
- Trichloroethylene
- Vinyl chloride

Each of these contaminants is known to present human health risks, both as a result of skin contact and as a result of consumption.

## **Injuries Caused By Camp Lejeune's Contaminated Water**

Several injuries and illnesses have been linked to Camp Lejeune's contaminated water. This includes a variety of skin conditions and internal disorders, as well as multiple forms of cancer and other injuries. Tragically, many mothers who bathed or drank the water at Camp Lejeune have experienced miscarriages and given birth to children with birth defects as well. Some examples of the conditions caused by Camp Lejeune's contaminated water include:

### 3. Handle the Administrative Process on Your Behalf

The Camp Lejeune Justice Act of 2022 requires all claimants to go through an administrative process. Our lawyers will handle this process for you, while keeping you updated and informed every step of the way.

### 4. Advise You Regarding Settlement Options

At some point during your Camp Lejeune water contamination claim, you may receive a settlement offer from the federal government. ## 5. Take Your Claim to Court if Necessary
