

Multi-vehicle accidents involving three or more vehicles are more complex than a typical car accident case. If you have been injured, you may be one of multiple people pursuing a claim against the same driver. Alternatively, you may have a claim against more than one person. Identifying the cause and determining what happened can also be more complicated. ## Types of Multi-Vehicle Accidents

Every car accident is unique and this is no different when the accident involves multiple vehicles. Identifying the particular type of accident you have been involved in can help understand what happened and how you should proceed. Generally speaking, every multi-vehicle accident falls into one of the following categories:

1. **Intersection accidents** where two vehicles collide and one or both then crash into other cars in the intersection.
2. **Rear-end accidents** are where one vehicle collides with another from behind and pushes it into the car in front of it.
3. **Bad weather accidents** are caused by dangerous road conditions and poor visibility.
4. **Chain reaction accidents** on highways and interstates where due to the high rate of speed and close proximity of other vehicles one accident causes multiple other accidents simultaneously.
5. **Highway mayhem accidents** where one car, typically driving at an excessive rate of speed, loses control and crashes into several other vehicles before coming to a stop.

Understanding the types of multi-vehicle accidents can help identify the cause of your accident and who may be at fault. That said, every case is unique and requires careful analysis of the facts. An experienced car accident attorney will be able to review your case and determine whether you may have a claim.

## Gathering the Evidence You Need in a Multi-Vehicle Car Accident

Multi-vehicle car accidents can be chaotic and, as a result, it can be extremely difficult to sort out what happened. Depending on where you were at the time the accident occurred, you may not even know how the accident began or who else was involved. In order to pursue a claim, you will need to gather evidence that supports your case. Unfortunately, this is often a challenge in multi-vehicle accidents, but here are some places to start:

- Photos of the damage to your vehicle and other vehicles
- Photos of the scene of the accident including where other vehicles came to rest
- Photos of any injuries you suffered
- Traffic camera and dashcam video footage
- Obtaining statements and contact information for other drivers involved in the accident and other witnesses

The [days following your accident](#) are important to the success of your case. If you failed to get this evidence at the scene of the accident, however, do not be alarmed - a multivehicle accident attorney can help gather the evidence you need to build your case.

## Can More Than One Driver Be at Fault in a Multi-Vehicle Accident?

One of the things that make multi-vehicle accidents complex is that the driver who hit you may not be the one responsible for causing the accident. Depending on the situation, the driver who hit you may not bear any responsibility. In other cases, you may have a claim against more than one driver.

For example, if you were rear-ended by another vehicle, you would normally pursue a claim against the driver who struck you. However, if that driver was pushed into you when they were struck by another driver, then you would pursue a claim against the driver who began the accident. But if the driver who struck you was tailgating or speeding, you may have a claim against both drivers if you can prove the driver who struck you could have avoided the accident had they been driving safely.

As you can see, multi-vehicle accidents can quickly become very complicated. A multi-vehicle accident lawyer can help you determine who should be held responsible for your injuries.

## Identifying All At-Fault Drivers Is Critical to Your Case

One of the reasons why multi-vehicle accidents are complicated is that you may have multiple parties pursuing a claim against the same driver. If that driver is able to prove that someone else is at least partially responsible for causing the

accident, it can significantly impact whether those claims are paid.

Furthermore, it's important to remember that North Carolina is one of a handful of states that follows the "pure contributory negligence" rule. Under this rule, any driver who may have contributed to the accident is barred from pursuing a claim for compensation. As a result, the at-fault driver may try to claim that you were also at fault as a way of avoiding liability.

Making an incorrect assumption about who is at fault for causing the accident can be disastrous. Knowing how to proceed is almost as important as the substantive aspects of your case. In addition, you need to carefully consider all of the evidence and who may be at fault in order to develop a successful legal strategy for pursuing your claim. For this reason, pursuing a multi-vehicle accident claim can be very difficult for non-lawyers. A lawyer with experience in handling multi-vehicle accidents will know how to proceed with your claim.

## You May Need to File Multiple Claims

Cases, where there is more than one at-fault driver, can be very complex. In short, you may need to file claims with multiple insurance companies in order to get the compensation you deserve. This means that you will likely need to negotiate with multiple different parties in order to settle your claim, which can be exhausting.

In addition, it is very likely that the parties will not agree on who was at fault or even what caused the accident. Disagreements over the facts and various legal issues can result in significant delays in the payment of your claim. More importantly, it also means that your case is more likely to proceed to litigation.

- Concussions and other traumatic brain injuries
- Neck injuries including whiplash

- Spinal cord injuries
- Facial injuries
- Broken bones
- Torn ligaments and tendons
- Internal organ damage
- Severe lacerations

It's not uncommon for many injuries to manifest themselves in the days following your accident. Do not assume that you cannot pursue a claim if you declined medical treatment at the scene of the accident. Listen to your body and get the treatment you need, and then discuss with a lawyer whether you should consider pursuing a claim.

## You May Be Entitled to Compensation
